

**ORDINANCE NO. 208**

**AN ORDINANCE MAKING APPROPRIATIONS FOR  
THE SUPPORT OF THE CITY OF GREY FOREST  
FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2014,  
AND ENDING SEPTEMBER 30, 2015, AND ADOPTING  
THE ANNUAL BUDGET OF THE CITY OF GREY FOREST  
FOR THE 2014-2015 FISCAL YEAR**

WHEREAS, the City of Grey Forest Budget, appended hereto as Exhibit A, for the Fiscal Year beginning October 1, 2014 and ending September 30, 2015, was duly presented to the City Council by the Mayor; a Public Hearing was ordered by the City Council; public notice of said hearing was caused to be given by the City Council; said notice was published in The Helotes Echo; and said Public Hearing was held according to said notice; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GREY FOREST, TEXAS:

SECTION 1. That the appropriations for the Fiscal Year beginning October 1, 2014, and ending September 30, 2015, for the support of the general government of the City of Grey Forest, Texas, be fixed and determined for said terms in accordance with the expenditures shown in the "City of Grey Forest October 1, 2014 to September 30, 2015 Fiscal Year Budget" appended hereto as Exhibit A.

SECTION 2. That the "City of Grey Forest October 1, 2014 to September 30, 2015 Fiscal Year Budget", as shown in words and figures in Exhibit A, is hereby approved in all respects and adopted as the City's budget for the Fiscal Year beginning October 1, 2014, and ending September 30, 2015.

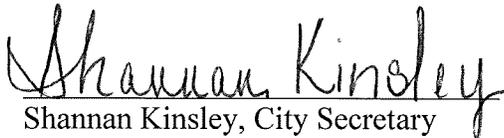

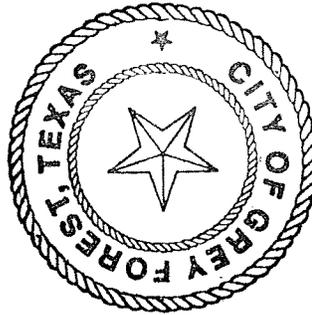
